On 27th February 2023, FDI Global CEO Mr Steven Tan inked a 30-year operations agreement with Lembaga Kemajuan Pertanian Pahang (LKPP) for a 600-acre

Aquaculture Farm located at Pekan, Pahang.

Witnessing the event are YAB Dato' Sri Haji Wan Rosdy bin Wan Ismail, Menteri Besar Negeri Pahang, YH' Dato' Suhaimi bin Mohd Yunus, CEO of Perbadanan Kemajuan Pertanian Pahang (PKPP), Tuan Haji Shahrumzaki bin Hassan, General Manager of Lembaga Kemajuan Pertanian Pahang (LKPP) and the Board of Directors from PKPP.

The **600-acre** Aquaculture Farm, consists of **271 ponds** and a processing plant with a cold storage capacity of **340 tonnes** will increase our group revenue by approximately RM 50 million with a projected profit of **RM 20 million** by the end of **2025**.




SECURING SEED SUPPLY

Our seed requirement is 4,500,000 pcs per month !









ASSURANCE OF SEED SUPPLY


